The Entering Scholars Program (ESP), has made significant gains in closing the achievement gap and in increasing completion of transfer level coursework (ENGL 100). For example, in fall 2016, first-time Hispanic students enrolled in an ESP class succeeded at a rate 7.3% higher than first-time Hispanic students not enrolled in an ESP class. ESP integrates high impact-practices such as embedded tutoring and counseling support, as well as introduces students to campus resources such as the Transfer Center and Financial Aid Office by bringing staff into the classroom to establish early and meaningful connections. Professional learning in also a key component of the program, with faculty and tutor trainings grounded in equity-minded practices from texts such as *Diversity & Motivation: Culturally Responsive Teaching in College*, the guidebook for *Teaching Men of Color in the Community College*, and *College Fear Factor*. We currently have eight 100-level (non-PTI) classes among 33 total ESP sections, which is approx. 900 students served in the program in fall 2017. The cost for the equity-funded portion of the program is \$40,000/year.
